Learning Connections - focuses on preventing severe academic difficulties or school failure by providing early intensive reading and math instruction for low-income children and resources and skill-building for their families. In FY2010, the Learning Connections program enrolled 551 students; 93% of students improved their academic skills as measured on pre and post-tests.

Assessment and Instructional Services - include learning disabilities, attention-deficit, and reading assessments; individual consultations; and 1:1 tutoring services to assist children, youth, and adults throughout Minnesota in improving their learning strategies and skills to meet their academic, vocational, and personal goals. LDA provided individualized and intensive services to 188 assessment and tutoring clients during FY2010; 94% gained self-knowledge and strategies to achieve their goals.

Parents as Partners - engages and enables parents to become more involved and better equipped to support their children's learning, including issues related to LD (learning disabilities) and ADHD. The program builds parent confidence to use their own strengths, and then empowers them with new tools, strategies, skills, and practical information that are sensitive to their culture and life situations. In FY2010, the Parents as Partners program served 1,176 parents; 100% of parents of pre-schoolers reported increasing early literacy activities with their children and 100% of parents of school-aged children gained useful information and strategies to support their children's academic success.
