We desire to demonstrate the great love of God and to give hope to hurting and needy people in all walks of life, worldwide through our actions and service. We are committed to reaching out to others throughout the world to help to meet their physical and spiritual needs.		
Describe what was achieved in carrying out the organization's exempt purposes. In a clear and concise manner, describe the services provided, the number of persons benefited, and other relevant information for each program title.		
28 During this fiscal year, Touching Lives Worldwide (TLW) has primarily been working in Haiti and the Dominican Republic. The programs and projects that were started in the previous fiscal year, continue to be supported. However, in this fiscal year that ended August 31, 2010, TLW has expanded their services and projects in some of the same communities and added other needy communities to the areas of their operation. In Hato Mayor, Dominican Republic, they continued to support a church and its programs that provides help to the needy in various ways such as food, employment, healthcare, and much more. There, TLW purchased and donated a parcel of land and started a process for building a Christian school and medical clinic on that property. They started multiple English/Bible classes for all ages. They have assisted many children and families with their special needs. In Dajabon, Dominican Republic, they have taken the necessary steps to provide a much needed school for deaf children. They have partnered with a church in helping provide desperate children answers to homelessness, food shortages, healthcare issues, and more. Also, TLW has provided classes to all ages for teaching them English, Bible, and trade school type training. They have financially provided medical care and medicine to individuals. They have helped numerous children, both Dominican and Haitian, that live on the streets of this border town. In the Port au Prince area of Haiti, TLW now has an orphanage for 54 children whereas they provide the deprived children with shelter, food, affection, protection, healthcare, and education. Also, TLW helps to support a school for approximately 300 children in an area where less than 25% of children get any opportunity to obtain an education.
