Clinical Training
Southwest Border AHEC offers community based education for health professions students to expose them to rural health care. The program also serves as a recruitment tool to stimulate the interest of these students to return to rural areas once they become health care professionals. During the fiscal year of 2009-2010, Southwest Border AHEC provided housing to 28 health professions students for a total of 91 weeks of training. The types of rotations included Physician Assistant, pharmacy and dental with specialty rotations in OB/GYN, pediatrics, orthopedics and for the first time, general surgery. Also, a new rotation for the first time was pharmacy; these students were from Texas A&M Health Science Center. All clinical training took place in Maverick or ValVerde counties where 3 apartments were available (2 in Eagle Pass and 1 in Del Rio) for the students. AHEC covered the costs of the monthly apartment fees including utilities (total \$19,175.18), monitored the use of the housing units, oriented the students to the locale and coordinated the student housing with the University of Texas Health Science Center San Antonio. With housing in Maverick and Val Verde Counties, students can maximize their learning in our rural areas.

College Enrichment Program
Southwest Border AHEC, in collaboration with Southwest Texas Junior College, conducted its first summer enrichment program for college students interested in entering the health professions. The purpose of this 2 week 80 hour program was to facilitate the entry of undergraduate students into medical and/or health care professional schools. The curriculum consisted of 4 enrichment courses designed to enhance student academic skills and competitive standing and included critical thinking, science enrichment, study skill and communication skills. A total of 13 community college students enrolled in the program with 100% graduating. Each student was provided with a \$100 stipend and each professor received a \$600 honorarium. Other training expenses included materials, supplies and snacks.

Health Career Summer Camp
In order to promote health career activities as a means of recruiting health care professionals, Southwest Border AHEC conducted a health career summer camp for the second time for high school students enrolled in the Eagle Pass Independent School District. A total of 31 students attended the one week 30 hour program from June 7-11, 2010. Activities included insights from health care professionals (including physicians, nurse practitioners, physician assistants), CPR training, skills practice, mortuary science career planning and college preparation, and trips to health care facilities. Expenses related to medical supplies, materials and other training costs. All students completed the program.
