THE ORGANIZATION ALSO OPERATES A KIDS PROGRAM THAT PROVIDES COMMUNICATION DEVICES AND INSURES THOSE DEVICES AS ITS SECOND TYPE OF ACTIVITY. THIS YEAR NO DEVICE WAS PURCHASED, BUT THE ORGANIZATION DID HELP COVER THE COST OF INSURANCE FOR ONE OF ITS MEMBERS. THE THIRD TYPE OF SUPPORT IS THE ADULT ACTIVITY PROGRAM. THE ORGANIZATION BELIEVES THAT BY TAKING ITS MEMBERS OUT TO EAT AND TO DIFFERENT ACTIVITIES IN THE COMMUNITY SUCH AS BOWLING, IT CAN HELP TEACH THE MEMBERS BEHAVIOR AND SOCIAL SKILLS AND ETIQUETTE WHILE ALSO BEING ENJOYABLE FOR THE MEMBERS AS WELL.
