During the 2009-2010 season, Madison Opera produced two performances of Carmen that were attended by over 4,200 people, four performances of Turn of the Screw that were attended by approximately 1,300 people, two performances of The Flying Dutchman that were attended by approximately 3,400 people, and a student matinee of Carmen that was attended by about 1,200 people. Madison Opera also produced Opera in the Park, a free outdoor concert, that was attended by an estimated crowd of over 14,000

Madison Opera held various educational programs during the year including three Opera Up Close events, a series of adult education events that were attended by over 300 people, a dinner event after a performance of Carmen that was attended by about 150 people, a prelude dinner event at Opera in the Park that was attended by about 200 people, and Opera Trips to the Lyric Opera in Chicago and to Ravinia Park in Highland Park, Illinois, with an average of about thirty individuals per trip
