Total cost of wishes granted for the fiscal year were \$381,437. Of this amount, \$42,130 was contributed by various vendors who provided in-kind contributions such as travel and travel services, transportation, lodging, and other services and use of facilities to complete a child's wish. For financial statement purposes, these amounts are included as contribution revenue and granted wish expense. For Form 990, however, the IRS requires the \$42,130 of contributed services and use of facilities to be excluded from both revenue and expense.
