	PHII, the Public Health Informatics Institute, was founded 11 years ago. It's mission is to improve the performance of the public health system by advancing public health practitioners' ability to strategically manage and apply health information systems. PHII collaborated with PATH (Program for Appropriate Technology in Health) and WHO (World Health Organization) on a project to establish the foundation of requirements for Logistics Management Information Systems (LMIS) that can be developed in one locale and shared with many others. Working with the CDC (Centers for Disease Control and Prevention) and the International Society for Disease Surveillance, PHII and its partners merged summary-level information from more than 40 state and local entities with other existing surveillance systems to become a key component in the H1N1 pandemic response.

4b	(Code) (Expenses \$ 7,106,347 including grants of \$ 5,623,673) (Revenue \$ 7,460,775)
	The Infectious Diseases Program includes the Lymphatic Filariasis Support Center (LFSC), Global Polio Antiviral Initiative (PAI), AMMRIRIA, and the National Viral Hepatitis Roundtable (NVHR). LFSC provides technical expertise to ensure a strong scientific base for the global elimination of LF. During the year, LFSC conducted large, multi-country trials to test a variety of diagnostic tools and identified two as the best tools to gauge the success of programs to eliminate LF. It also developed a major initiative to streamline and digitize data capture and management using smart-phone technology. PAI (Polio Antiviral Initiative) was launched in 2007 to facilitate research and development of poliovirus antiviral drugs as supplemental tools for worldwide prevention and control of poliovirus incidents that may occur after polio eradication and oral polio vaccine cessation. During the year, PAI continued researching candidate drugs being considered for the antiviral. NVHR is a coalition of public, private and voluntary organizations dedicated to reducing the incidence of infection, morbidity and mortality from viral hepatitis in the US. AMMRIRIA was launched in December 2009 to support the Measles Initiative in achieving accelerated measles mortality reduction targets and improved routine immunization in sub-Saharan Africa.

4c	(Code) (Expenses \$ 6,424,571 including grants of \$ 1,047,834) (Revenue \$ 9,951,949)
	The Disease Control and Eradication Programs include Children Without Worms (CWW), the International Trachoma Initiative (ITI) and the Mectizan Donation Program (MDP). CWW provides donated Mebendazole from Johnson & Johnson for treatment of soil-transmitted helminths (intestinal worms). During the period, 35,640,000 doses were donated to treat children in 7 countries. MDP provides pharmaceuticals donated by Merck for the prevention and control of onchocerciasis (river blindness). During the period, MDP shipped sufficient Mectizan for 100,420,444 treatments in 33 countries in Africa, Latin America and Yemen. ITI provides donated Zithromax from Pfizer Inc. for treatment of blinding trachoma. During the period, 39,105,984 treatments (POS and tablet form) of Zithromax were donated to treat communities in 12 countries. All pharmaceutical transactions are reported on the 990 tax return of Global Health Solutions, Inc., a supporting organization of The Task Force for Global Health, Inc.
