Three Rivers AHEC – Connecting Communities to Health Care 2010 Report to the Community (September 2009—August 2010)

The mountains start here. The land ends here too. Georgia is a state of variety and contrast. The people who live here are as diverse as the landscape, and each one deserves access to quality health care. Three Rivers AHEC is committed to meeting this crucial need. We are a community-driven, nonprofit organization with the mission to build and sustain a health care workforce for the communities in the Three Rivers AHEC region. We address our mission through strategies that impact the recruiting, training, and retaining of healthcare professionals based on a “grow your own” approach.

Recruiting

Health Careers Awareness: initiatives that increase the competitiveness, readiness, and number of disadvantaged and minority youth in the higher education applicant pool

- ~Conducted 103 programs for 3,550 participants from our region and border counties and states – 63% of the participants were classified as disadvantaged, 69% minority, and 48% both.
- ~Developed and implemented the Knights Academy—a 21-week program conducted for two 8th grade classes at the East Columbus Magnet Academy (Muscogee County). The students were educated in all areas of health careers through guest speakers, presentations, games, group activities, and worksheets. The goal of the Academy is to assist the students in making a more informed decision regarding their high school diploma designation.
- ~Awarded 13 scholarships to assist students as they pursue their health career education – each scholarship was \$250. The students participated in the 4th *Chart the Course Academy*,— a year-long program which immerses qualified high school seniors into the depths of a variety of health careers. The students hailed from Harris and Muscogee Counties. Since the Academy’s inception, we have awarded \$11,500 in scholarships to 46 students who have successfully completed the Academy. **Where are they now?** 43 are attending 14 schools in Georgia, Alabama, South Carolina, and Kentucky with the following majors declared (2 have completed the training and are employed in a health career and 4 are undecided):

Training

Clinical Training/Preceptorship: a network of community-based training sites and support to reduce the barriers so health professions students can obtain the required clinical training hours

- ~Enlisted 145 health care providers who served as volunteer community faculty (preceptors) and trained 279 students (53% minority) during 417 clinical training rotations for 69,949 training hours. Training occurred in 22 of the counties in our region.
- ~Provided housing support for 115 clinical rotations (value of \$69,750) and travel support for 46 clinical rotations (value of \$2,300) in our region.
- ~Coordinated clinical training in our region, provided housing or travel support for 26 health care professions program graduates who are employed in our region. Since 2001, 415 graduates have remained in our region to work.

~*The Anchor: Clinical Training in West Central Georgia* is a partnership between Three Rivers AHEC and the Georgia Campus: Philadelphia College of Osteopathic Medicine (PCOM). Ten PCOM medical students are living in Columbus while they complete their required 3rd year training in hospitals, medical clinics, and physician offices in Columbus, Ft. Benning, and LaGrange. The 4-week rotations are in each of the following areas: Emergency Medicine, Internal Medicine, Family Medicine, Pediatrics, Psychiatry, OB/Gyn, and General Surgery. Nine 4th year PCOM medical students are completing their audition rotations for the residency selection process and will begin their core rotations the fall of 2010 in Columbus. The Anchor is recognized as a “best practice” in addressing the physician shortage in Three Rivers AHEC region and is being replicated in other AHEC regions in Georgia.

Retaining

Continuing Education: programs for health professionals focused on quality care for patients via increased clinical competencies and for licensure requirements

~Co-sponsored 16 continuing education workshops and conferences which 1,605 health care professionals attended to increase their clinical competencies – 87% needed the education for licensure requirements. Awarded 4,089 continuing education contact hours to health care professionals.

~Ensured that the workshops and conferences were of good quality – the overall evaluation score was 4.83 with 5.0 being excellent and 99% of the participants rated the programs excellent or good.

~Co-sponsored programs with 14 partners which generated \$24,597 in revenue

~Coordinated the RN Reentry Program (approved by the Georgia Board of Nursing) for a registered nurse who needed the program to return to work in a clinical setting. This program will assist in addressing the current nursing shortage in our region.

Learning Resources: educational support through learning resource services to reduce professional isolation, support lifelong learning, and enhance the practice environment which aid in the retention of primary care providers in rural Georgia

~Distributed access information for the OVID collection of databases to 424 of our clinical training preceptors and students (2,059 searches were conducted) to support community-based training. OVID is funded by the Medical College of Georgia. 80% of our survey respondents rated the service as good or excellent and that the knowledge gained as critical or necessary.

~Provided access to services and resources for 1,520 transactions which included library services and literature availability notifications.

Distance Learning Education: HealthTec[®] is a statewide distance learning program designed to support health professionals and strengthen services provided by nonprofit health organizations in Georgia.

~Produced 4 modules for on-demand training titled, "Managing Asthma Triggers" in partnership with Georgia Asthma Advisory Coalition and Georgia School Nurses Association

~Broadcasted a two-part live webinar titled, "Treating Older Adults: Depression, Anxiety, & Cognitive Problems" in partnership with the Georgia Geriatric Education Center and Magnolia Coastlands AHEC— 49 participated in the online training with 186.5 continuing education contact hours awarded.

~Broadcasted a live webinar for advocacy training in partnership with the Arthritis Foundation, Southeast Region, Inc. – Georgia— 24 participated in the online training.

~Provided technical assistance to West Central Georgia Cancer Coalition and the Georgia Asthma Advisory Coalition who are utilizing the HealthTec[®] technology to conduct two of their quarterly board meetings. By providing this technical assistance for these organizations, we join in their efforts to establish and achieve their capacity building goals as part of their sustainability plan in these distressing economic times.

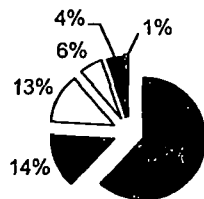

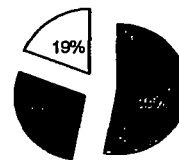
