If any covered person discloses a potential or actual conflict, the following procedure is followed: (1) the conflicting interest is fully disclosed to the board, (2) The covered person responds to any factual questions from the board related to the disclosed conflict, and (3) the Board, without the covered person, discusses the conflict and approves or disapproves the proposed transaction.
