PROGRAM GUIDELINES

Eligibility and restrictions

- * Application must be made by the creative author of the final work.
- * Applicant must have resided in Texas for at least 1 year prior to the application date.
- * All genres of film or video are given equal consideration. AFS is unable to consider multimedia projects.
- * Projects must be "independent productions", meaning under the artistic, budgetary and editorial control of the individual owning copyright. No consideration will be given to industrial or promotional pieces or "works-for-hire".
- * Application must be for the production, post-production or distribution stages. No consideration will be given for applications requesting pre-production or development funds.
- * AFS staff and Board Members and TFPF interns are ineligible to apply.

CRITERIA FOR REVIEW

Essential factors considered by panelists include:

- * The quality of the proposed work based on the description, realistic budget, and supporting materials
- * The likelihood that the work will be completed.
- * The applicant's demonstrated ability and creativity as seen in the representational work (film video, or script) submitted.

Applicants are asked to submit:

- * Application form and budget
- * Project description (1-3 pages)
- * Project timeline (1 page)
- * Optional support material (no more than five pages)
- * Proof of TX residency
- * Video sample
