This program affects all citizens in our local area. Some of the projects include: 321 Jump Start which provides literature and pamphlets for school age children. The faith based committee hold a prayer breakfast each year with a speaker of reknown in this field along with other prayer related functions. The Drug Endangered Child program informs the public of the issue of children in families where drug/abuse is evident. ADCC also has programs for children living in or removed from their homes due to drugs and crime. The Sticker Shock project works to inform older children of the danger of drugs and alcohol.
