


The purpose of Gutenberg College is to provide a liberal arts education in an environment respectful of biblical Christianity, leading to a Bachelor of Arts degree. As part of this program, certain other expenses are incurred, such as Plant Costs, Student Services and Auxiliary Enterprises (Residency and Meal Services).

4b (Code) (Expenses \$ including grants of \$) (Revenue \$)

Biblical/Christian worldview training: The McKenzie Study Center seeks to promote a clear understanding of the Christian gospel and its personal, social and cultural implications for todays people. This objective was pursued through classes, writing, and counseling. Between 50 and 70 people regularly attended public classes and discussion groups; ten issues of a monthly newsletter addressing biblical worldview issues were produced and sent to 2,000 subscribers; and much of the staff's teaching on biblical worldview issues was recorded and made available to the public on the Internet.

The purpose of Art Project is to promote an integration of the biblical worldview and the arts. This was accomplished by providing space and accessibility to artists' work, and by organizing and hosting several concerts and performance events. The staff of the Art Project also provided tutoring and guidance services to students and community members interested in the arts.
