Grants to the Center for Jewish-Arab Education in Israel supported new programs in early childhood education, high school development, community outreach initiatives, teacher training and curriculum development. In particular, support for Hagar school in Beersheba Israel helped that school grow and add a toddler program. Support for the Jerusalem school helped create a pilot communications and film-making program. Two academic conferences were organized dealing with Hebrew-Arabic bilingualism in education. In addition, numerous foreign dignitaries visited Hand in Hand schools including ambassadors to Israel, European diplomats, elected officials and others. Two youth delegations from Hand in Hand schools visited Europe. A new educational website for Hand in Hand was created. Numerous articles appeared in the Israeli press about the Hand in Hand schools. Grants to the Center in Israel made a clear impact for strengthening bonds between Arab and Jewish children, parents and the wider community. These grants helped solidify the model of integrated and bilingual education for Israeli society.

Hand in Hand organized a second youth exchange with the USA. A delegation of 21 students from Hand in Hand's Jerusalem school came to Portland, OR in March 2010 for a two week visit hosted by students at Metropolitan Learning Center, a Portland public school. Two Hand in Hand students came to the Los Angeles area in March 2010 to present their school in meetings at churches, synagogues, local high schools and public events. Co-founder Lee Gordon and NY representative Maura Milles gave over 30 lectures and presentations about the program to educators, community leaders and donors throughout the US. Events were held in New York, Los Angeles, San Francisco, Portland, OR, Chicago, Florida, Baltimore, Washington DC, Greensboro, NC, and elsewhere. Numerous articles appeared in the US press about the Hand in Hand schools.
