1 Briefly describe the organization's mission

Park Century School was founded in 1968 as an independent, not-for-profit, coeducational day school to meet the needs of children with learning disabilities. It serves a diversity of students, ages 7 to 14, of average to superior intellectual potential, in an optimal educational environment, while providing a developmental and therapeutic support system for the whole child. The guiding philosophy of Park Century School is based on the conviction that learning disabilities are life-long challenges that affect the total existence of a child and family. All children with learning disabilities need educational, emotional, and social assistance. Many also must have help with attention, organization, memory, language, and perceptual-motor function. Simultaneously, their families may be overwhelmed and exhausted by psychological stress, economic burdens, and confusion about the future. These conditions require a broad spectrum of therapeutic and educational interventions.

INTEGRAL PARTS OF THE PROGRAM ARE COMPUTER AND STUDY SKILLS, PHYSICAL EDUCATION AND PERCEPTUAL MOTOR SKILLS, ARTS AND ENRICHMENT, AND, IF NECESSARY, SPEECH AND LANGUAGE THERAPY. STUDENTS ARE HELPED TO DEVELOP A POSITIVE SELF IMAGE, SET REALISTIC GOALS AND LEARN SKILLS AND STRATEGIES NECESSARY TO RETURN TO A TRADITIONAL SCHOOL. PARENT EDUCATION AND PARTICIPATION WITHIN A TEAM APPROACH ARE ESSENTIAL TO EACH STUDENT'S INTELLECTUAL, EMOTIONAL, SOCIAL AND MORAL DEVELOPMENT.
