Business Lending Program Eastern Maine Development Corporation's Loan Department is designed to provide existing or start-up businesses with special financing needs Its objective is to create quality job opportunities and stimulate economic activity EMDC’s role as a secondary lender is to work with banks and other private and public funding groups to leverage the capital available to small businesses EMDC has several secondary loan funds to finance a wide variety of business needs, including equipment, real estate and working capital Through our lending programs, EMDC offers direct loans of \$1,000 to \$4,000,000, creatively packaged with partners in the banking and investment communities Since the inception of the program, in the early 1980's, EMDC has disbursed nearly \$60 million to over 500 companies, leveraging nearly \$187 million in other private and public funds Over 10,000 jobs have been created or retained EMDC currently has approximately \$13,400,000 in loan funds outstanding to 133 clients

Maine PTAC Program The Procurement Technical Assistance Program (PTAC) was set up under Title 10, United States Code, Chapter 142 in Maine PTAC is a statewide program which offers guidance to Maine businesses on issues related to government contracting Currently, it serves over 700 businesses that have requested assistance During 2010, Maine PTAC sponsored 29 outreach events including training workshops and Matchmaker events and participated in 17 non-sponsored outreach events The program also provides a Bid Match service to clients and supplies them with relevant information about government contracting through brochures, newsletters and a website www.maineptac.org Clients assisted by the Maine PTAC have reported government contract awards of over \$194 Million during fiscal year 2010

Workforce Investment Act Programs (WIA) EMDC provides job training services to eligible low income youth, adults, migrant and seasonal farmworkers and dislocated workers These services are delivered free of charge through the One-Stop Career Center system in partnership with the Maine Department of Labor The primary funding sources for EMDC's Workforce Development Services include 1 The Workforce Investment Act (WIA) - for Adult, Youth, Dislocated Workers and Employers 2 Pathways Grant - A two year construction, electrical, and plumbing job training project serving approximately 150 individuals from Penobscot and Piscataquis County and resulting in 7 new replacement homes for pre 1976 mobile homes 3 The Healthcare Project- Serving approximately 100 incumbent workers or unemployed individuals from Penobscot, Piscataquis and Hancock counties in the Healthcare industry 4 The Disability Employment Initiative grant (DEI) - serving both job seekers and businesses in Eastern Maine 5 National Emergency Grants (NEG) - for Dislocated Workers laid-off due to a company closure or mass-layoff 6 National Farmworker Jobs Program (NFJP) - for employment and training services to Maine's migrant and seasonal farmworker population 7 Competitive Skills Scholarship Program (CSSP) - for economically disadvantaged individuals who wish to pursue a post-secondary education in a high-wage, high-growth, high-demand occupation 8 American Recovery and Reinvestment Act (ARRA) - for Adult and Dislocated Workers who want to retrain in specific high demand occupations including IT, Health Care, Energy and Green Jobs 9 American Recovery and Reinvestment Act (ARRA) - Summer Youth Employment Program for disadvantaged youth age 16-24 EMDC will serve approximately 1,600 eligible individuals during Program Year 2009/2010 with the following types of services Basic Education Services including literacy and computer skills training, GED and High School Diploma programs, and tutoring servicesEmployability Services including career assessments, career counseling, Work Readiness Training, job matching and search including referrals to job openings, resume and interviewing skills, and career exploration, Supportive Services such as help with books and uniforms, travel and child care assistance, and other supports as needed Training Services that may be delivered to individual workers- or in concert with an employer - include - Individual Training Accounts (ITA) This is an "account" established on behalf of a participant with an approved training vendor that pays for needed education or training Adult and dislocated workers use the Account to "purchase" training services from eligible providers they select in consultation with their Career Advisor The program pays associated tuition, fees, books and other costs - On the Job Training If a worker qualifies and is seeking a new skill set, EMDC can reimburse up to 50% of the wages to an employer while the worker is training on the job This helps defray some of the costs associated with providing needed skills to new employees - Work Experience Is an activity designed to provide a planned, structured learning experience that takes place with an employer for a limited period of time Work experience may be paid or unpaid, as appropriate The participant also receives training and assistance in finding full or part-time employment once the work experience ends
