


worked together on very significant national campaigns. In January, for  
example, SFP organized Martin Luther King Day of Service programs in 12  
states from Connecticut to California, and Florida to Washington  
involving 15,397 volunteers in 261 service projects. This was our fifth  
year as a lead agency with the Corporation for National & Community  
Service for the Martin Luther King Day of Service. As a lead agency,  
SFP provides grants and support to communities throughout the nation.

In 2010, SFP conducted 15 major service projects under the title Global  
Peacemakers. These programs, involving international volunteers, last  
from 10-14 days and are designed to improve the quality of life in poor

For example, Altos de los Pinos, a rural community in Honduras, hosted  
a 12-day GPM program in March, 2010 with 25 volunteers from over 10
