

The Interfaith Board of Directors continues to be committed to Interfaith's mission "to provide low-income persons and families, rental housing and related facilities and services", primarily in Amherst, Massachusetts and the abutting communities.

Interfaith's President, Richard O. Johnson, died in December 2008. He had been a primary motivator in setting Interfaith's direction and in initiating and cultivating relationships that would impact its future grant making.

The Board of Directors was reconstituted in 2009 and 2010, and has been working to realize the goal of establishing a residence for the homeless in Amherst. This ambitious project for purchasing and renovating the desired Amherst real estate (purchase price of \$1.4 Million, renovations, not including substantial improvements required), necessitates that Interfaith partner with another charitable organization which has initiated its own fundraising effort for the project. A partnership with a service organization qualified to run the facility will also be needed, and all will join together to seek state grants to complete the project.

This plan was initiated in March 2009. An offer on a property in Amherst made in December 2009 remains on the table as the current owner of the property supports the proposed use.

The total purchase price offered for the property was \$1,400,000. Because at least \$500,000 would be provided by Interfaith, it continues to treat \$500,000 as set aside and dedicated to this single purpose. Interfaith funds have been used to obtain an appraisal on the property. Recent contributions of \$30,000 (to be reported on the 2010 return) were made to a cot program at a local church, serving as a seed project to the ultimate homeless housing project plan currently under way.
