Served 100 students in one hour a week sessions combining music, speech and social skills training together in a seamless and highly motivating program that develops speech, social interaction and communication. 125 students were served in the training program.

VOICES TOGETHER EDUCATION PROGRAM

Voices Together in Education brings together students with developmental disabilities and two board-certified music therapists for weekly sessions that weave music, language, cognitive, social and behavioral skills into motivational learning experiences that correlate with NC Department of Education core curricula and IEP goals. Approx. 300 students were served in 2010 at Durham Public Schools and Orange County Schools with positive results in the areas of self-determination, self-expression, communication, speech and social interaction. The number of students served represented an increase over the 50 served in 2009.

VOICES TOGETHER SINGER PROGRAM

Brings together a performing group of musicians with developmental disabilities. Musicians rehearse once a week and work on vocal technique, diction, part-singing, and musical pieces. The group continued to have 15 participants in 2010 - the same as in 2009.
