The Food Trust, a non-profit organization founded in 1992, addresses the need for stable, nutritious, and non-emergency food supplies in neighborhoods. We work to build strong communities through healthy food, and decrease the high rates of diet-related disease, such as obesity and Type 2 diabetes, in lower-income neighborhoods through improving access to healthy food and providing nutrition education.

The Food Trust partners with schools and after-school programs in the Philadelphia, Norristown, and Reading regions to teach children and their parents about healthy eating. The organization provided nutrition education lessons and activities to 50,000 students in the Philadelphia, Reading and Norristown school districts, as well as about 1,000 youth in after-school and summer camp programs in 33 City of Philadelphia recreation centers.

The supermarket campaign is an innovative program to increase the availability of fresh, affordable food in low-income areas. Through the fresh food financing initiative, a \$40 million leveraged fund to support supermarket development, the Food Trust works to attract new grocery stores to underserved communities statewide and collaborates with government, civic, and industry leaders to implement public policies that improve access to healthy food in all neighborhoods. The organization conducted an advocacy initiative to encourage supermarket development in underserved communities in a dozen states nationwide, in Pennsylvania, where the campaign started, 83 new or improved supermarkets are serving an estimated 500,000 residents.

The Food trust developed the Healthy Corner Store Initiative to increase the availability of healthy foods in corner stores and to educate young people about healthy snacking through nutrition education in schools and the Snackin’ Fresh Crew Youth Leadership Program. This pilot program is active in five North Philadelphia communities. The program engaged 2400 urban youth in learning about healthy food choices in corner stores and worked with a network of 40 corner store owners to provide technical assistance and resources THAT increase access to fresh, healthy food.

The School Market Program promotes healthy eating and provides nutrition education to students in the Southeastern Pennsylvania area through nationally recognized, student-run, fruit and vegetable markets in schools. The program oversaw student-run school markets in 23 public schools in Philadelphia, Norristown, and Reading, where students sold fresh fruits and vegetables in schools to promote good nutrition and health snacking. The farmer's market program brings fresh, affordable and nutritious food to community farmers' markets every week from June through November, throughout the region. The program provided an estimated 125,000 customers with access to fresh, locally grown fruits and vegetables through a network of 30 farmers' markets in Pennsylvania.
