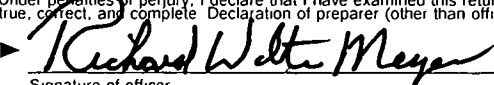

The foregoing requirements, however, are not be construed to prevent a particular board member from briefly stating his/her position on the matter, nor from answering pertinent questions of other trustees or committee members by reason of the fact that personal knowledge on the matter may be of assistance to the other board or committee members in reaching their decision.
