The program is a collaboration between public and private organizations in the Cities of San Diego and Escondido. The project targets at-risk youth who are referred by teachers, counselors, law enforcement, and parents. Thirty-eight AmeriCorps members annually mentor 550 young people.

4b (Code: ) (Expenses \$ 332,748 including grants of \$ 0 ) (Revenue \$ 0 ) The Peace Empowerment Program (PEP) consists of the Violence Impact Form, Circle of Peace, designed to end the cycle of violence and parent peace coalition programs. Each of these programs are integrated together into the Peace Empowerment Program with a full-time TKF coordinator residing at each school. Approximately 850 violence-prone, at-risk middle school youth are helped.
