The Negev Foundation is an Ohio not-for-profit corporation, which was formed on October 21, 1991. This foundation was formed for the purpose of directly conducting and/or supporting through grants research connected with the development and improvement of techniques and technology for growing produce and crops in deserts, arid and semi-arid areas.

The Negev Foundation conducts and/or support research connected with the development and improvement of techniques and technology for growing produce and crops with brackish-salty-water ("brackish water research") at the Ramat Negev Agricultural Experiment Station ("Ramat Negev") located in the Ramat Negev are of the Negev Desert in Israel.

Ramat Negev is an agricultural research facility operated by the Ramat Negev Agricultural Experiment Station Fellowship Society (the "Fellowship Society") (a Fellowship Society being the Israeli equivalent of a U.S. not-for-profit organization). The research facility, approximately 100 acres in size, essentially is an agricultural research laboratory at which experimentation of techniques and technology for growing crops without fresh water resources and in arid-like terrain is carried on. The research facility is the preeminent facility for arid land agricultural research.

The Fellowship Society currently employs 5 scientists (2 full-time and 3 parttime) to conduct agricultural research at the Ramat Negev facility, 3 technicians to monitor and maintain systems at the facility, 5 field laborers, a secretary and a security guard. The research facility is available for use and is used by other organizations involved in arid-land agricultural research. The results of the research conducted by the Fellowship Society at the research facility are made available to the public on a nondiscriminatory basis and without charge (the primary users of such results currently being collectives located in the Negev Desert). Almost all of the funding for the research facility and research conducted by the Fellowship Society now comes from the Jewish Agency, a quasi-governmental agency in Israel.

A significant area of research being performed at the research facility is brackish water research. Brackish water located in subterranean reservoirs constitutes the most easily available water supply in the Negev Desert of Israel and, therefore, presents the best hope of making many areas agriculturally productive. Brackish water is pumped from beneath the Negev Desert to the research facility where it is used in experimentation aimed at developing techniques and technology for growing produce and crops with brackish water.

PART III (a) cont.

The Negev Foundation desires to assist and expand the brackish water research conducted at Ramat Negev for the public benefit with the goal and purpose of making the results of such research available to the public on a nondiscriminatory basis. To that end, The Negev Foundation sponsors research projects carried on at the Ramat Negev research facility (both by the Fellowship and other persons and organizations, U.S., Israeli or otherwise, involved in such scientific research) and to fund infrastructure and research facility improvements at the Ramat Negev needed to expedite brackish water research. Also, The Negev Foundation will consider funding other agricultural research relating to desert, arid and semi-arid land agriculture.

The Negev Foundation operates independently of the Fellowship Society. The Negev Foundation solicits research grant applications from persons and organizations (including Fellowship Society) and will be solely responsible for deciding which of the submitted research projects to sponsor and the terms for sponsoring such research (which will require that the research be made available on a nondiscriminatory basis). The Negev Foundation also will be solely responsible for deciding the research facility and infrastructure improvements at Ramat, Negev, which it will fund. The Fellowship Society will not have any claim to the assets of The Negev Foundation. The Negev Foundation may create an advisory panel consisting in part of agricultural scientists to advise on the approval of grants, which may include a representative of the Fellowship Society.
