Starr Commonwealth's mission is to create positive environments where children flourish. A full continuum of community-based, family preservation, early intervention, and specialized residential programs are offered in Michigan and Ohio. Education and training programs are offered for childcare professionals, clinicians, educators and parents. All programs and services are rooted in the belief that every child has strengths. Treatment services enable each young person to identify and cultivate their strengths in ways that enable them to achieve their full potential.

	In 2010, 617 youth were served in specialized residential treatment programs addressing behavioral issues such as juvenile delinquency, sex offending behavior, substance abuse and mental health issues often associated with the traumatic experiences of abuse, neglect, victimization and violence. Among the indicators of success found one year after program completion are that over 80% of youth reported that they were more productive, had not been arrested, charged or convicted of a crime, were attending school and achieving passing grades, were alcohol/drug free and reported they were better off as a result of receiving services from Starr. Starr tracks each youth for a period of one year post-placement, follow-up calls are made to parents, case workers, probation officers, and youth.

	Community based programs include a range of services that are generally intended to keep families intact, when possible, and to meet the needs of children in their homes, their schools and their communities. These programs prevent out-of-home placement, and also assist youth who have required services away from their home transition successfully back into the community. In 2010, 1,446 youth and their families were served in Starr's community-based programs which included Treatment Foster Care, Supervised Independent Living, Structured Transitional Living and Day Treatment. Among the indicators of success found one year after program completion are that over 80% of youth reported that they were more productive, were attending school and achieving passing grades, had not been arrested or charged for any violations of law and reported that they were better off as a result of receiving services from Starr. Over 90% reported not having been convicted of a criminal offense. Starr tracks each youth for a period of one year post-placement, follow-up calls are made to parents, case workers, probation officers, and youth.
