CHANGES IN PROGRAM SERVICES:

Tuition Assistance Program - Due to escalating expenses and reduced revenues, the governing body elected to suspend indefinitely all payments for the Tuition Assistance Program. This decision was influenced by the Chrysler bankruptcy in 2009. However, the Board left open the possibility of reinstating the Tuition Assistance Program should economic conditions improve. Other Program Services:

Health & Safety Training: The program provides training in the plants to advance and promote safe work practices and safe working environments. Employees are trained to identify and eliminate safety hazards in the workplace. This program also educates employees on the importance of personal protective equipment e.g. safety glasses, ear plugs and gloves. The goal is to provide a safe work environment with reduced injuries and lost time incidents. This leads to improved quality and productivity. Expenses - \$243,261

Artist at Work: The Artist at Work program allows Chrysler employees to showcase and display their creative talents. Employees submit their artistic entries and winners are selected from a panel of experts. Entries can be sculptures, paintings, photography, pottery, jewelry making etc. The artwork remains on display at various Chrysler locations for one year and then is returned to the owners. \$122,893

Product Quality Improvement: This program provides training and education to UAW employees to promote quality improvement in the manufacturing plants. This group provides training to help employees identify quality problems and causal factors. In addition, this group provides problem solving training using a variety of time tested and proven techniques. The goal of this program is to improve product quality and consequently improve sales, profitability and job retention and growth. Expenses \$120,225

Kokomo Training Center: The Kokomo Training Center is essentially a satellite training center for UAW employees in the Kokomo, Indiana area. The facility provides training for employees in the area of safety, computers and new hire training. Although this is the smallest of the UAW Chrysler training facilities, it still provides needed training services for UAW employees who cannot conveniently attend training classes in the Detroit area. Expenses \$99,751

The 990 form is prepared by the accounting staff at the UAW CHRYSLER SKILL DEVELOPMENT & TRAINING PROGRAM. Upon completion of the preparation process, the form is reviewed by the Controller. Copies of the filing are made available to the governing Board at the next quarterly Board meeting.
