**Technical Assistance to Community & Migrant Health Centers & Homeless/Capacity Building Assistance**  
From July 1, 2009 to June 30, 2010, Migrant Health Promotion has participated in twelve monthly meetings with other Cooperative Agreement Awardees (CAAs) currently known as Farmworker Health Network (FHN). The Farmworker Health Network (FHN) designed a Turn the Curve plan which allows each organization to coordinate efforts, activities and reporting of work accomplished with the Migrant Health Centers and farmworkers. From January through May 2010, MHP and Health Outreach Partners worked collaboratively to evaluate and design a new outreach program for Community Health Development, Inc. (CHDI) a M/CHC in Ulvalde, Texas. Migrant Health Promotion actively collaborated with Migrant Clinician's Network (MCN) to present a 6.0 hour training entitled Lance Armstrong LiveSTRONG Cancer Survivorship Training for Lay Health Workers at the 2009 East Coast, Midwest and West Coast Migrant Stream Forums. The FHN has developed and completed a national needs assessment for M/CHCs to determine their T/TA needs for meeting program requirements set by HRSA. As of June 30, 2010, the Capacity-Building Program has provided 15.25 hours of funding technical assistance to 18 M/CHCs or an average of 0.85

**CDC-Nuestro Futuro Folic Acid Promotion Program**  
In its third and final year, the Nuestro Futuro program completed 1,776 in-depth individual encounters and 506 group encounters for the year ending September 2010. Project staff completed an interactive folic acid promotion curriculum in both English and Spanish. This curriculum was distributed at national and local conferences and is available for download from Migrant Health Promotion's website. Other activities included developing placards displaying foods rich in folate to display in local restaurants; creating a fotonovela (photo story) to promote peer health education about folic acid consumption; and creating magnets and attractive forms for program participants to sign and display in their homes to remind them of their commitment to consume folic acid and share the information they learned with their families and friends. Nuestro Futuro closed the year by training 30 Promotoras/Community Health Workers from other local agencies and clinics to implement the Nuestro Futuro curriculum.

**Health Resources and Services Administration-The Community Based Doula Program**  
There were a number of exciting systems changes that occurred as a result of this project. In order to understand the magnitude of these changes, it is important to understand that the childbirth practices in south Texas are many decades behind the rest of the country. Things long ago accepted as good childbirth practices such as having family or individuals to support the mother during delivery, strong support for breastfeeding as the healthiest option for mother and child, and decreased routine medical intervention during childbirth are not practiced in the program area targeted. In fact, many of these practices were actively opposed. Because of this, one of the programs proudest moments came this year when the local hospital prominently posted a large sign - in both Spanish and English - allowing a birthing coach to accompany clients during labor. Our program staff and participants had worked long and hard with hospital staff, local providers, and other key actors to achieve this key activity. This signaled an enduring system change in the way mothers and families would be treated in the future.

Assistance) hours of TA per M/CHC. In Year Two of the 2008-2011 grant period, 10 new Promotor(a) programs were started with support and assistance of Migrant Health Promotion. Migrant Health Promotion provided technical assistance to 91% of new Promotor(a) programs through technical assistance and program training. Overall, Migrant Health Promotion has surpassed the objective of supporting the start of four new programs and providing technical assistance to 75% of new programs. A narrative of more detailed accomplishments are available by request.

Our Program Coordinator was a key participant in both the Valley Primary Care Consortium (Healthy Start) and the Rio Grande Breastfeeding Coalition. The Valley Primary Care Consortium (breastfeeding committee) was particularly active and effective making the acceptance of breastfeeding a key goal within our communities. In this campaign, the breastfeeding committee has established 23 local restaurants as "breastfeeding establishments" which included signs publicly displaying their support for breastfeeding and providing lovely cover ups for moms (that were theirs to keep) who wished to breastfeed in their restaurants. Another key accomplishment was the development of a provider that is very supportive of Doulas and the healthy outcomes resulting from more advanced childbirth practices. He has become an advocate for the program and the practices espoused by the program, often interceding with the hospital and other medical systems to facilitate change. Specifically, he is very supportive of participants having vaginal births, allowing Doulas be very involved in participants pregnancy as desired by the client, and supporting Doulas and clients during labor to obtain programs outcome ( vaginal birth, no epidurals, and breastfeeding initiation). Most importantly, 49 healthy babies were born under the care of our Doulas. All of these babies and mothers had established medical homes, were referred and successfully enrolled in WIC, Medicaid and CHIP, and became breastfeeding pairs. As noted in our data submissions, none were low or very low birth babies and health outcomes for both mother and child were significantly better given our target population. Finally, the mothers served by this program were well satisfied with the services provided. Of the 49 served, 42 rated the overall experience "excellent" with the remaining 7 rated "Good". All 49 participants noted that the Doulas were instrumental in communicating their needs to the nurse and explaining the components of the birthing process. Most telling, all 49 would recommend Doula services to others.
