The Wisconsin Early Childhood Association's child and adult care food program helps pay for nutritious meals and snacks served to children in regulated family child care home settings. The program pays a fixed amount for each meal and snack served that meets the U.S. Department of Agriculture's standards. Family child care providers are trained in program rules and proper nutrition for children. During the year WECA served approximately 1,600 family child care providers throughout Wisconsin.

(Code) (Expenses \$ 4,061,914 including grants of \$ 3,343,452) (Revenue \$)

The T E A C H Early Childhood scholarship and reward stipend program promotes professional development within the child care workforce through scholarships that offer financial support to pay most of the costs of tuition, books, travel, release time, and a bonus after the student successfully completes a scholarship contract, in exchange for a commitment by the student to remain in their job for a specified period of time. WECA administers this program under contract with the Wisconsin Department of Children and Families (DCF) with federal funds from the U.S. Department of Health and Human Services Child Care and Development Fund (CCDF). During the year WECA served 1,093 early childhood professionals through the T E A C H program. The R E W A R D program is a compensation initiative that awards stipends to early childhood professionals based on education already attained and years worked in the field. WECA administers this program under contract with DCF with federal funds from CCDF. WECA provided 1,558 stipends this year.

WECA provides health and safety training workshops under a professional service contract with the Milwaukee County Department of Health and Human Services. WECA is responsible for the development and presentation of trainings, workshops, and in-services in health and safety issues to include topics that have been identified as low-scoring for Milwaukee County childcare providers. During the year WECA provided these trainings to 1,423 individuals. WECA also provides continuing education classes and customized trainings and workshops for the early childhood workforce throughout the Wisconsin. WECA charged fees to cover the costs of these trainings. Over 2,600 individuals attended these classes and workshops. In addition, WECA hosted its 55th Annual State Conference. Highlights of the conference were the professional development luncheon and the keynote speakers at the opening and closing of the conference along with many workshop sessions for the participants to enjoy. Approximately 650 individuals attended the conference.
