The cornerstone of WBD's success is the delivery of the SBA 504 product. At 9/30/10, the portfolio included 1,088 loans totaling \$482,217,259. During the reporting period, 153 loans totaling \$84,119,574 were funded which created or retained 1,625 jobs. WBD provides loan packaging services for the 7(a) program. This program provides SBA loan guarantees of up to \$1,500,000 for business start ups, expansions, acquisitions, and operational expenses. During the reporting period, 79 type 7(a) loans were packaged by WBD. These loans supported the creation or retention of 856 jobs and \$38.97 million of total project values. Through our partnership with various community development agencies, WBD provides loan servicing and back office support enhancing the agency's ability to deliver the services they provide. These agencies include, but are not limited to the following: Forward community investments, Waukesha county economic development corporation, first American capital corp., Milwaukee economic development corporation, and Wisconsin business development growth fund, Inc.
