OUR LARGEST PROGRAM IS HEADSTART WHICH IS A CHILD DEVELOPMENT PROGRAM THAT PROMOTES SCHOOL READINESS AND PROVIDES COMPREHENSIVE HEALTH, NUTRITIONAL AND SOCIAL SERVICES TO ELIGIBLE THREE, FOUR, AND FIVE YEAR OLD PRESCHOOLERS AND THEIR FAMILIES. THE PROGRAM FOCUS IS ON HELPING PRESCHOOLERS DEVELOP THE EARLY READING AND MATH SKILLS THEY NEED TO BE SUCCESSFUL IN SCHOOL. 99% OF OUR FAMILIES RECEIVED PARENTING INFORMATION, 369 INFANTS AND CHILDREN COMPLETED MEDICAL AND DENTAL EXAMS, 97% OF PARTICIPATING INFANTS AND CHILDREN ARE UP-TO-DATE ON IMMUNIZATIONS. OUR ENERGY ASSISTANCE PROGRAM ASSISTS PARTICIPATING HOUSEHOLDS TO MAINTAIN AFFORDABLE, CONTINUOUS AND SAFE HOME ENERGY.
