SOMEPLACE SAFE PROVIDES FREE AND CONFIDENTIAL ADVOCACY SERVICES TO VICTIMS AND SURVIVORS OF DOMESTIC VIOLENCE AND THEIR CHILDREN, FAMILIES AND SUPPORT SYSTEMS IN WEST CENTRAL MINNESOTA. SINCE OPENING A REGIONAL EMERGENCY SHELTER IN 1979, SERVICES HAVE CONTINUOUSLY ADAPTED AND EXPANDED TO MEET GROWING NEEDS AND DEMAND. SOMEPLACE SAFE'S SERVICES HAVE GROWN TO INCLUDE ASSISTANCE FOR VICTIMS AND SURVIVORS OF SEXUAL VIOLENCE AND GENERAL CRIMES, AS WELL AS SUPERVISED PARENT-CHILD VISITATION AND EXCHANGE SERVICES. PROGRAMMING INCLUDES NINE COMMUNITY OUTREACH OFFICES COVERING AN EIGHT COUNTY AREA, FIVE PARENTING TIME CENTERS, EMERGENCY SHELTER FOR BATTERED WOMEN AND THEIR CHILDREN, AND A THRIFT STORE.
