Housing Augustana Care owns and manages a variety of older adult living communities in Minnesota. Each of the campuses has comfortable living and care options for older adults. Housing options include apartments for independent living, housing with services, and assisted living. In 2010, 1,617 older adults resided in housing either owned or managed by Augustana Care. Expenses shown are for the Augustana Care Services portion of expenses related to management of the housing communities.
