THE BHC FOUNDATION'S PRIMARY EXEMPT PURPOSE IS TO COLLECT, AGGREGATE AND PUBLISH THE FINANCIAL AND QUALITY METRICS FOR HEALTHCARE FACILITIES THROUGH THE ST. LOUIS AREA HEALTH CARE INDUSTRY OVERVIEW. THESE REPORTS ARE DISBURSED TO KEY STAKEHOLDERS AND THE PUBLIC AT LARGE WITH A GOAL OF INCREASING TRANSPARENCY IN THE ST. LOUIS REGION.

TO PROMOTE THE EFFICIENT AND ECONOMIC DELIVERY OF HEALTH CARE TO THE GENERAL PUBLIC, AND IN CONNECTION THEREWITH: TO ENCOURAGE AND SUPPORT COST EFFECTIVE PLANNING AND COST EFFECTIVE DELIVERY OF HEALTH CARE EDUCATION, HEALTH CARE FACILITIES, AND HEALTH CARE SERVICES IN THE ST.
