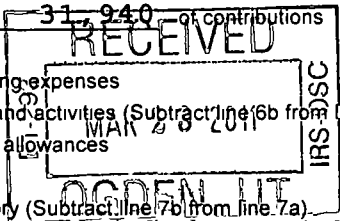



The organization's 990-EZ has been amended to adjust the balance of a loan from a member of the Board of Trustees. The balance of the loan was decreased by \$1,000 to reflect a \$1,000 payment made on last day of the fiscal year which was omitted from the original 900-EZ. The balance of the loan was increased \$6,000 and contributions were reduced by \$6,000 because debt forgiveness was recorded in error in the fiscal year ended September 30, 2010. The board member had forgiven \$6,000 in the prior fiscal year and an entry was made in the current fiscal year as well. However, no forgiveness of debt occurred in year ended September 30, 2010. The net effect of these adjustments is a \$1,000 decrease in cash, a \$5,000 increase in the balance of the loan, and a \$6,000 reduction in the amount of contributions previously reported on the organization's 990-EZ

Lydia Johnson Dance creates and performs original choreography which is made available to the general public, schools, community centers and other venues in order to educate and inform the public on the process of choreography and dance in general.
