21st Century LeadersThis flagship program of 21st Century Leaders, Inc. is a leadership development program for high school youth from across the state of Georgia that includes a series of one-week, residential leadership program on collegiate campuses, weekend retreats and service days and additional leadership opportunities through our Youth Advisory Board and social enterprise internships. Sample achievements in 2010 include - This program served 662 high school youth from 168 schools - One new additional summer program week was launched, increasing the number of summer program weeks to a total of 5 and expanding summer program capacity by 28% Each student received over 55 hours of hands-on, experiential training during the summer institutes - Student participation at weekend retreats and leadership events increased by 35% - Programs and activities were led by 535 volunteers from the business and professional sector - Sample outcomes include- 97% of students report an overall improvement in their leadership skills, 94% report improvement in their communication skills and 98% of students report becoming more comfortable working with people who are different from themselves, 55% report coming to the program having never held a leadership position, 98% report feeling equipped for a leadership role in the future as a result of their experience with 21st Century Leaders and 93% report becoming inspired to seek out a leadership role in the coming year, 94% report being more confident in networking with peers and adults as a result of their 21st Century Leaders experiences
