PARC’s Discovery Learning Center - the children’s early intervention programs include full-day special education, physical, occupational and speech therapies, a family focused homebound program with behavioral supports, home respite services and outreach for infants and children with developmental delays and disabilities Each child’s ultimate goal is to enter into typical kindergarten at age five A celebration ceremony is conducted each year for the Pre-kindergarten class as they graduate into the public school Early Intervention services to over 190 children per year assist in meeting important milestones Each child has an individualized plan that is comprehensive and includes families and siblings Nursing services and health training are provided ongoing to each child and family PARC’s toddler computer lab is designed specifically for children to learn and experience technology along with experience in a multi-sensory environment Over 40 children are provided with transportation to and from the center with no fee charged to the families Four times each year a workshop is provided for families in areas of positive parenting and behavior focus, encouraging success at home and school
