The Sharing Center provided assistance to 14,191 families in fiscal year 2009-2010. 11,456 families received food; 5,507 families received clothing; 3,396 families received medical assistance; 711 families received shelter assistance; 950 families received utility assistance; 308 families received transportation assistance; 300 families received shoes and school supplies for Back to School; and 676 families received new shoes for their children for Christmas.

Thrift store - During fiscal year 2009-2010, the thrift store sales totaled \$447,797, which proceeds were used to further the mission of The Sharing Center.
