Flood Assistance Program - provides a combination of low interest loans, due on sale loans and grant assistance for the repairs to owner-occupied properties that were damaged by flooding that took place in Nashville, TN in May, 2010 Assistance is provided to enable clients to meet financial gaps that may occur between the cost to repair their property and proceeds received from federal and local disaster relief programs In 2010, there were 182 families served, with committed funding of \$4M for repairs, with \$605K lent in 2010, the organization received contributions of \$1,201,700 and received federal grants of \$732,594
