In 2002-2003, TEDC loaned approximately \$496,000 to businesses in Tulsa utilizing its CDBG and SBA loan programs. The loans made by TEDC over the past several years have resulted in over 103.5 new jobs for 2002-2003 in the Tulsa area, with over half of the jobs filled by individuals in the low-to-moderate income range.
