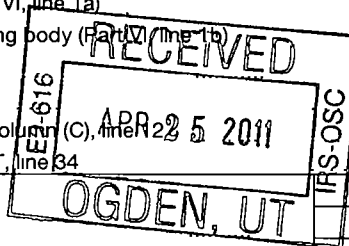

preparation of tax returns for limited-income households (to ensure
full tax benefits and refunds are claimed and received).

affordability gap of \$160 million. We advocate to keep energy costs

economic security concerns of low income families.
