Social Services - The Organization provides food, clothing, medical
aid, shelter, financial assistance and other emergency and temporary
services to individuals and families in the local community without
charge.

During fiscal year 2010, we have fed 3,565 families (129% of goal); we
have clothed 300 children (125% of goal); and we have provided special
assistance to 574 families (120%) of goal. The special assistance
includes utility assistance, prescription assistance, and public
transportation assistance - all in the form of vouchers. These services
have been provided at an average cost per family of \$40.07.

Counseling - The Organization provides treatment planning, individual
and family counseling, educational programs and training. The
Organization conducts education and training programs for community
organizations, professionals and churches. The Organization also
provides pastoral care by a priest, on site, to all who wish it.
Pastoral care includes worship services, the sacraments of the church,
pastoral counseling, pastoral visits and prayer requests.
During the first three quarters of this fiscal year, we have provided
counseling to 748 families/individuals (113% of goal). All
families/individuals have received an average of ten sessions of
counseling. These services have been provided at an average cost per
counseling session of \$49.56.

Thrift Store - The Organization operates a thrift store in the Portland
metropolitan area, the net earnings of which support direct services to
clients. The store provides work experience and on-the-job training to
workers needing assistance entering or re-entering the labor force.
The store functions as a clothing and household goods supply center for
social service clients.
During the first three quarters of this fiscal year, we have provided
low cost clothing and/or household items to 57,050 people (119% of
goal). Our average sale is \$10.51; and our cost to process donations
and operate our store for that same sale is \$8.16, generating 30%
'profit' which supports counseling and social services.
