Both Auxillaries are departments of Asante and thus related to the Asante Foundation. However, since the Auxillaries fall under the tax ID number of Asante and not the Foundation, management felt it appropriate to include them in their list of contributors.

Schedule J, Part II shows the compensation of the Officers, Directors, and Key Employees of Asante, as well as the compensation of the Top 2 highest paid employees. Columns Bi, Bii, and Biii displays the amounts actually paid to these people as what shows up on their Form W-2 on December 31, 2009. Columns C and D include amounts accrued, but unpaid during the fiscal year, with column E being total compensation reported for form 990 purposes. Column F includes amounts that had been reported as accrued but unpaid compensation on prior year form 990 tax returns, but paid-out during the current year.

During fiscal year 2010, Roy Vinyard and Marvin Haas received significant pay-outs from their Executive Restoration Plans, Voluntary Deferral Plans, and Capital Accumulation Plans. These Plans had been accumulating funds for several years and had shown up on prior year's form 990 as accrued but unpaid amounts. However, they were not actually paid-out until fiscal 2010. The paid-out amounts are included in Schedule J, Part II, column Biii and would be included in the Officer's form W-2 on December 31, 2009.

Also, since these current pay-outs were displayed as accrued but unpaid amounts on prior year's form 990, the Schedule J's instructions require they also appear on

The Asante Foundation's primary exempt purpose is to raise monies and in-kind donations to further the exempt purpose of Asante, a 501(c)(3) hospital and healthcare system which services the healthcare needs of the citizens of southern Oregon and northern California.

Form 990, Part III, Line 4a - Program Service Accomplishments

During the tax year, the Asante Foundation's largest program service accomplishment was the granting of \$1,358,191 to benefit various departments and capital projects at Rogue Valley Medical Center (RVMC), a 378 licensed bed hospital located in Medford, Oregon. Of the capital projects, over \$550,000 was donated to the Neonatal Intensive Care Unit (NICU) remodel and expansion. This capital project will almost double the overall size of the NICU and add an additional 10 bassinets and giraffe beds. All new high efficiency lighting and patient monitoring systems will be included in the project. Once completed, the overall increase in patient volume is expected to be modest, but the major focus of the new expansion is to increase the efficiency and quality of care to the babies and their families.

Another major capital project includes the completion of the fundraising campaign to purchase a new \$5 million state-of-the-art radiation tomotherapy machine. The new tomotherapy machine will deliver a precise beam of radiation and can irradiate cancer cells as small as a grain of sand while having minimal or no affect on surrounding tissues. This new machine is expected to save or extend the lives of thousands of cancer patients in the area. Other capital projects include the donation of \$93,000 towards the purchase of a new central patient monitoring system for the Pediatrics department.

In addition to donations for capital projects, the Asante Foundation also helps

support numerous clinical departments at RVMC. This includes a generous donation of over \$26,000 to the Hospice department. The NICU and Pediatrics departments received over \$140,000 of donations during the year. Other donations help support the Dubbs Cancer Center, the Women's Imaging Center, the Emergency Department, Behavioral Health, and the Francis Cheney Family Place.

Form 990, Part III, Line 4b - Program Service Accomplishments

The Asante Foundation's second largest program service accomplishment is the granting of \$189,939 to help support various departments and capital projects at Three Rivers Community Hospital (TRCH), a 125 licensed bed hospital located in Grants Pass, Oregon.

During the tax year, the Foundation contributed over \$20,000 toward the purchase of an Infant Hearing Tester, as well as another \$20,000 toward completing the landscaping of the Three Rivers Family House. Another \$25,000 was donated to purchase two Verathon Bladder Scanners for the hospital's surgery department.

In addition to supporting capital projects, the Foundation also made contributions to various clinical departments of the hospital. This includes the Spears Cancer Center, the Women's Imaging Center at TRCH, and Obstetrics departments, Digital Imaging, and the Emergency Department, to name a few.

Finally, the Foundation was successful in applying for and receiving generous grants from the Susan B Komen Foundation and the Care Oregon Fund. The \$22,500 grant from the Komen Foundation was used to supplement the cost of mammograms. This helped to increase the number of women in Josephine County receiving mammograms who may not otherwise be able to afford one. The Care Oregon Award will help improve patient care processes for glycemic management for diabetes patients and for post-operative nausea and vomiting.

The Asante Foundation's third largest program service accomplishment is the granting of several scholarships to various individuals and organizations in southern Oregon and northern California.

During the year, the Foundation gave a \$66,700 scholarship to the Rogue Community College School of Nursing. This scholarship donation will help subsidize the cost of tuition and lab fees for college nursing students. Other scholarships have gone towards leadership and clinical training programs.

Finally, the Asante Foundation has made donations to the Asante Chaplain Services and to Asante Community Service's Lifeline monitoring service.

The Asante Foundation's on-going mission is to continually assess the needs of both hospitals it supports, as well as the community we serve. Over the years, the Foundation has contributed millions of dollars to help subsidized important clinical departments of the hospitals and help purchase needed medical equipment. It has also made significant contributions to major building projects at Rogue Valley Medical Center and Three Rivers Community Hospital.

The draft return is reviewed by Asante's Chief Administrative and Finance Officer and Director of Finance. After the review, Accounting will clear all review notes. The Asante Foundation's Board of Directors will look over the final set of returns and make further comments or

corrections, as is appropriate. Once all reviews and corrections are made, the CAFO will sign all appropriate returns for filing. The return will then be filed either electronically or paper copy with the appropriate government agencies. A copy of the return is to be kept in Asante's Accounting department and another will be kept at Asante's corporate headquarters for public display and copying, as requested.
