3. THE AUTHORIZED BODY SHALL ADEQUATELY AND TIMELY DOCUMENT THE BASIS FOR ITS DETERMINATION THAT THE AUTHORIZED TOTAL COMPENSATION FOR THE EXECUTIVE IS JUST AND REASONABLE CONCURRENTLY WITH MAKING SUCH DETERMINATION. THIS MAY BE ACCOMPLISHED IN PART BY INCLUDING WITH THE MINUTES THE COMPARABILITY DATA OBTAINED AND RELIED UPON BY THE AUTHORIZED BODY AT THE MEETING IN WHICH THE DETERMINATION WAS MADE.
