In general, the foundation makes grants only for specific projects and does not provide funds for endowment or building programs, for grants to individuals, or for annual fund raising campaigns. Unfortunately, many worthy requests must be turned down each year, either because needs far exceed the foundation's limited resources or because a given project does not fall within the current program guidelines.
