In 2010, the Minnesota State Fair Foundation granted \$318,758 to the State Fair for capital and program improvements including lighting improvements at the Fine Arts Center, development of the State Fair archives, and vocabulary building and history programs during the State Fair. This amount does not reflect an additional \$33,977 of in-kind services that the Foundation received and granted to the State Fair. Additionally, other funding was provided to advance agriculture and the environment. Cumulatively, since the start of the Foundation in 2001, over \$4 million of cash and in-kind contributions have been made to the State Fair. The Foundation also retains assets for future grants. The Foundation's operating expenses are funded through contributions, earned income and the State Fair.
