The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. The guidance on accounting for uncertainty in income taxes also addresses de-recognition, classification, interest and penalties on income taxes, and accounting in interim periods. There were no unrecognized tax benefits identified or recorded as liabilities at October 31, 2010 and 2009.

The Organizations' policy is to include interest and penalties relating to uncertain tax positions in interest expense and operating expense, respectively.

Form 990 filed by the Organizations is subject to examination by the Internal Revenue Service (IRS) up to three years from the extended due date of each return. Forms 990 filed by the Organizations are no longer subject to examination by the Internal Revenue Service for years before 2006.
