Governing documents, conflict of interest policy, financial statements and annual audit are available to the public by request. Summary financial information, list of donors, and lists of all funded programs are provided in the Annual Report that is printed and distributed to donors and legislators, as well as posted on the KHC website.

A Membership Committee comprised of active members of the Board of Directors present the names of prospective members to the full board at the annual meeting. The full board votes on the nominated slate of board candidates.

The full board acts on any actions or decisions made by the Executive Committee and presented to the members.

*Part VI, Section A, lines 8.a., 8.b.

Minutes of all meetings of the full Board of Directors, the Executive Committee of the Board, or any other subcommittee are recorded and distributed to all members for approval.

All employees can be reached at the organization's address but members of the Board of Directors are volunteers who reside throughout the state of Kansas. See SCHEDULE O ATTACHMENT for a list of current board members and their addresses.

15.a. The Chair of the Board of Directors along with other members of the Executive Committee conducts an evaluation and job performance review of the Executive Director. They then discuss this evaluation and recommend the level of remuneration with the full board.

15.b. The Executive Director conducts an annual review of each employee - and with each employee. The results of these evaluations are shared with the board, who then determine the salary levels for the ensuing fiscal year.
