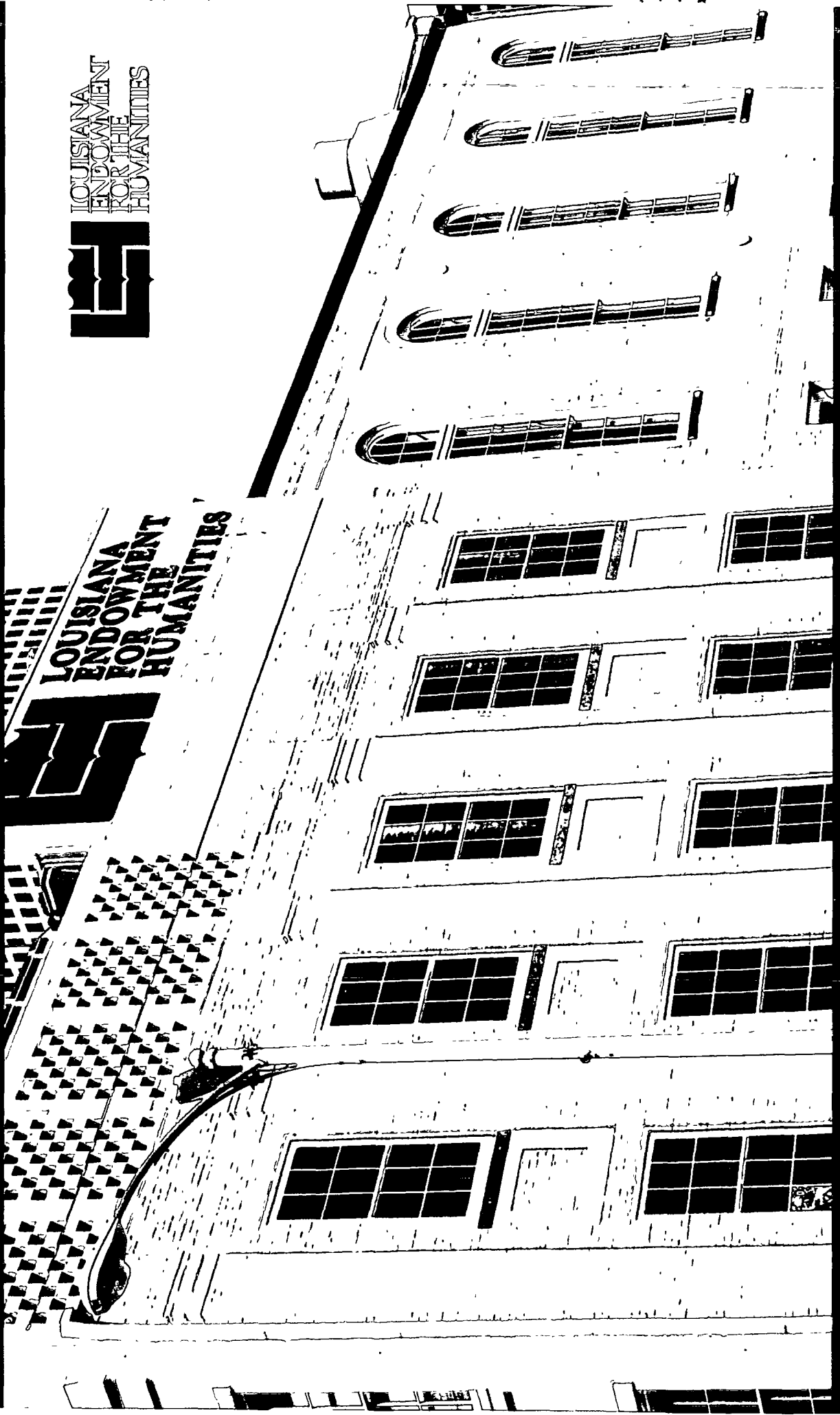

RELIC: READINGS IN LITERATURE AND CULTURE

For almost three decades, Readings in Literature and Culture (RELIC) has offered adult readers the opportunity to engage in diverse and intellectually challenging reading and discussion of literary and historical texts in the humanities in local libraries across the state.

RELIC's topics speak to the experiences of Louisianians as residents of the state and as American citizens interested in humanities-related topics. RELIC serves as a gateway for individuals to engage the worlds of ideas and expression about the human experience, and as a vehicle for libraries to diversify their role in their communities. Small towns and rural areas, as well as newcomers to Louisiana, particularly benefit from these quality programs.

Reaching 63 of Louisiana's 64 parishes since 1983, the scholar-led reading sessions have been held in libraries across the state. RELIC has attracted a total attendance of over 98,800 – from all accounts the most widespread and well-attended series of reading projects in the nation. RELIC is the Louisiana Endowment for the Humanities' longest running program.

Acknowledging the extensive reductions in funding from the State of Louisiana, RELIC began to cultivate local partnerships with the goal of securing community-based funding for programs. In 2010, the LEH conducted 21 programs in part with over \$30,000 in local funding.

- Conducted programs in 13 subjects, including Louisiana history and literature, World War II, Creoles in Louisiana, Louisiana in the Civil War, Elizabeth I of England, American immigration, and the culture of north Louisiana
- Drew into discussions 2,797 participants in 24 programs for an evening session average of 20 persons
- Delivered programs in 24 locations in 22 parishes throughout the state with 13 of them in rural communities and small towns

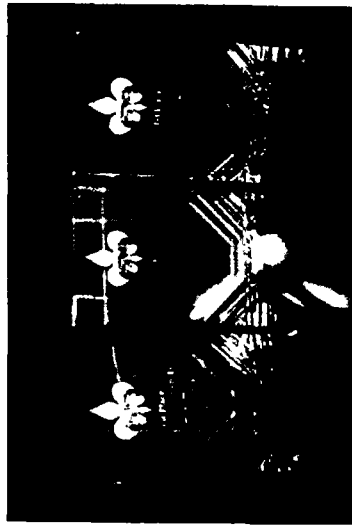
Louisiana Cultural Vistas celebrated its 21st year of publication in 2010, maintaining its mission to document and interpret the state's culture, literature, arts and history. The Press Club of New Orleans honored the magazine with twelve awards in 2010, adding to a total of 108 awards received in the past 18 years. The quarterly magazine ensures that grant projects that may have reached a select regional audience gain greater visibility on the printed page, circulated to more than 50,000 readers.

An on-line version of the magazine was launched with the Spring 2007 edition, allowing Internet access to each page of subsequent issues as well as the eventual goal of digitally archiving all back issues. By logging on to www.leh.org, readers can now find *Louisiana Cultural Vistas* in its entirety in a Web-based format.

The Deepwater Horizon oil spill of April 2010 prompted the magazine to focus content on the natural environment and cultural history of the Louisiana wetlands. As it did in the aftermath of Hurricanes Katrina and Rita in 2005, *Louisiana Cultural Vistas* will serve as a forum for documenting the upheaval and recovery from this unprecedented disaster.

Highlights of 2010 included:

- A history of steamboat traffic on the Red River
- Paintings of Avery Island and the coastal wetlands by New Orleans artist Simon Gunning
- A profile of music legend Allen Toussaint
- A photo essay of the rural North Louisiana town of Keachi in the 1970s
- A biographical sketch of famed World War II General Claire Lee Chenault, commander of the illustrious "Flying Tigers"
- A fiction excerpt of the short story "Saving Fats," by Pulitzer-prizewinning writer Sam Shepard

Since 1992, *Louisiana Cultural Vistas* has been honored with 108 awards from New Orleans Press Club competitions

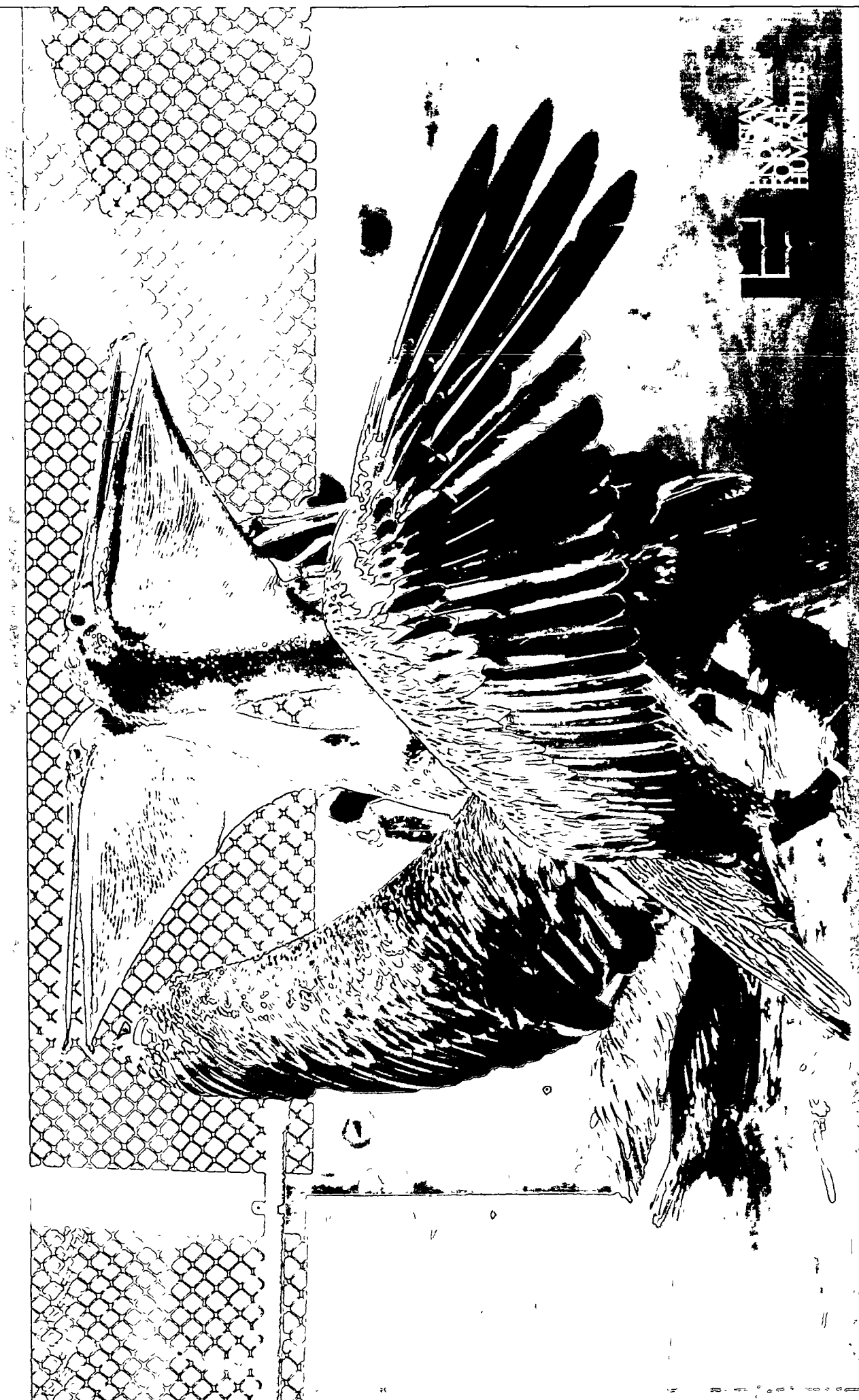
