In determining each individual's compensation the Committee utilizes the most recent California Regional Executive Compensation Survey Report prepared by Integrated Healthcare Strategies (formerly known as Clark Consulting). This survey provides executive compensation data (including benefit data) from 120 California health systems and hospitals. The Hospital pays senior executives both a base salary and an incentive bonus based upon both the organization's and the individual's performance. Base salaries are paid at the midpoint between the 50th and 75th percentiles for California hospitals of similar size based upon annual net revenue. Annual incentives allow the individual executive to achieve up to the 75th percentile of total cash compensation for good performance. The 75th percentile was chosen given the fact that 1) net revenue for the hospital fails to adequately state the complexity of the organization because net revenue is understated by virtue of the fact that over-all revenue is deflated by the hospital's large Medi-Cal percentage and the fact that it is classified as a disproportionate share hospital and, 2) the hospital does not provide common senior executive benefits such as a supplemental retirement plan, supplemental life insurance, supplemental long-term disability insurance and long term care insurance. 80% of the individual annual executive incentive awards are based upon measurable objectives established at the start of the fiscal year by the Governing Board's Executive Committee. The objectives include quality, financial, and business development components. The remaining 20% of the incentive awards are awarded at the discretion of the Executive Committee. Target incentive awards are set at 20% of the Executive's base salary, with the exception of the CEO, whose target incentive award is set at 25% of base salary.

Valley Presbyterian Hospital's three maternity plans are as follows: Normal Delivery - Up to a 2 day stay - \$2500C-Section - Up to a 3 day stay - \$4000, C-Section - 4 day stay - \$ 5500. If during the admission, you choose to have a circumcision completed on your child, it is included in the maternity plan. If a decision is made to perform the procedure on an outpatient surgery basis, the cost will be \$800 for the hospital fees only. Payment Plans - Your balance is due upon discharge from the hospital. If you do not qualify for state assistance or our financial assistance program, you may establish payment arrangements with our financial counselor. Payment arrangements may be made with no interest penalties. Defaulting on your payment plan disqualifies you from taking advantage of this option. Tony Cardenas Community 2010 Health FairCouncilman Tony Cardenas brought together over 30 organizations including city, county, state and federal departments for his Community Health and Safety Fair. VPH offered blood pressure screenings to attendees and free information on cardiovascular health. In addition, the VPH Amputation Prevention Center provided educational information on preventing amputations, and also provided foot screening. Over 2,000 community members attended the event. H1N1Valley Presbyterian continues to be vigilant in enforcing policies and procedures to minimize exposure to the H1N1 Flu (a.k.a., Swine Flu) by our patients and staff. VPH continues to be proactive and implement measures that educate people who are exposed to highly transmissible diseases such as H1N1 Flu. As in 2009, VPH has continued its educational campaign. VPH formed an H1N1 Task force comprised of a multidisciplinary group of 25 people across different departments in the hospital, to address specific needs of the H1N1 pandemic.
