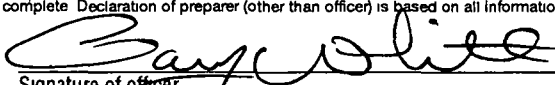

KBA provides seminars throughout the year to provide opportunities for continuing education for the various departments in broadcast stations. These areas include, Advertising Sales, Programming, Engineering and Legal/Regulatory matters. These seminars are essential to the associations mission of providing relevant information to its members.

The broadcast industry is regulated by the Federal Government and the Federal Communications Commission. These agencies frequently attempt to impose legal or regulatory standards that may be supportive or sometimes detrimental to association members. At times, such action may be an added burden on broadcasters and may affect their ability to serve the public as mandated by the FCC. KBA has set up the Washington D.C. Leadership program to cover these expenses, which allows association representatives and its members the ability to convey their position(s) to legislators and regulators on matters affecting the industry.
