In 2009, Friends of Acadia (FOA) and Maine Coast Heritage Trust (MCHT) purchased approximately thirty-five acres of marsh land on Northeast Creek for the sum of \$28,406. MCHT holds 51% ownership and FOA holds 49% ownership. FOA also granted \$21,730 to MCHT to purchase five acres of wetlands on Bass Harbor Marsh. These two properties have been sold to Acadia National Park. As planned in 2010, Friends of Acadia and Maine Coast Heritage Trust acquired a portion of land on Lower Hadlock Pond. The remaining land is under option for acquisition by Acadia National Park in 2012.

The Carriage Road maintenance grant makes possible the salaries of six Acadia National Park workers who perform regular maintenance of the park's 44 miles of historic carriage roads. In 2010, the workers repaired all winter storm damage including surface damage, erosion and tree falls. Crews were kept busy for weeks repairing winter and spring washouts, and spent approximately a week recovering and resetting coping stones that had been dislodged due to storms and vandalism, and added surface material and graded major equestrian routes. This program also uses thousands of volunteer hours from our volunteer and Acadia Youth Conservation programs. In addition, the AYCC youths split ten cords of firewood for the campgrounds.

The Island Explorer is a fare-free, seasonal, propane-powered bus system that runs through Acadia National Park and its surrounding gateway communities. Since its first day of operation in 1999 almost 3.7 million passengers have ridden the bus, approximately 1,373,687 private vehicle trips have been eliminated, reducing smog causing pollutants by an estimated 20.1 tons and green house gas emissions by 12,992 tons. Friends of Acadia has been involved with the bus system since its inception, granting \$2 million in funding, and securing more than \$2.05 million in grants from L.L. Bean to enable continued growth. Friends of Acadia's grant supplements the operating costs of 25 buses on Mount Desert Island and 1 on the Schoodic Peninsula.
