GEO HAS A SEPARATE AUDIT COMMITTEE RESPONSIBLE FOR OVERSIGHT OF THE AUDIT. THE AUDITORS REPORT DIRECTLY TO THIS COMMITTEE THROUGHOUT THE AUDIT PROCESS.
